## **2017 "YOUTH SERVICE WORKER" AWARD Nomination form**

Purpose: To annually recognize one youth service worker that has done an outstanding job assisting youth.

Eligibility: A "line-worker", who provides direct service to Steuben County Youth. The nominated individual must be a current or recent employee with a positive "track record". Ideally, a career youth service worker, educator, etc. – one who is committed to youth!

Nominating: The individual may be nominated by any person familiar with the individual's work, but please no family members. There is no limit to the number of nominations, but multiple nominations do not guarantee selection. The attached nomination form must be used.

Selection: A finalist will be selected by the Steuben County Youth Board. Selection will be based on the person's actual deeds, performance and impact.

Recognition: The finalist will be announced at the Youth Bureau's Annual Dinner meeting, tentatively in late January, 2017.

Deadline: All nominations must be received by the Steuben County Youth Bureau no later than **November 30, 2016**.
