I. CALL TO ORDER

Mr. Roush called the meeting to order at 10:20 a.m. and asked Mr. Mullen to lead the Pledge of Allegiance.

II. APPROVAL OF MINUTES

MOTION: APPROVING THE MINUTES OF THE DECEMBER 5, 2016, AND DECEMBER 19, 2016, MEETINGS MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

III. LANDFILLS

A. *Bid – Leachate Treatment Facility SCADA System Replacement Design & Construction* – Mr. Spagnoletti informed the committee that the SCADA system runs the leachate facility and is no longer being supported. They put out a bid and received four responses back. He recommends awarding to the low bidder, Plant IQ for a total cost of \$225,463 inclusive of Additive Bid No. 2 and Additive Bid No. 3.

MOTION: AWARDING THE BID FOR THE LEACHATE TREATMENT FACILITY SCADA SYSTEM REPLACEMENT DESIGN & CONSTRUCTION TO THE LOW BIDDER, PLANT IQ FOR A TOTAL COST OF \$225,463 INCLUSIVE OF ADDITIVE BID NO. 2 AND ADDITIVE BID NO. 3 MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

Mr. Spagnoletti informed the committee that he has \$150,000 available in the SCADA System Replacement capital project. He requested authorization to transfer \$64,804.92 from the Upgrade/Replace Scales capital project and \$30,658.08 from the Pave/Fence Wayland Transfer Station capital project into the SCADA System Replacement capital project.

Mr. Malter asked why are you transferring extra? Mr. Spagnoletti replied we will need parts for backup. That should only be about \$5,000 - \$10,000, but this will give us a little cushion.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO TRANSFER \$64,804.92 FROM THE UPGRADE/REPLACE SCALES CAPITAL PROJECT AND \$30,658.08 FROM THE PAVE/FENCE WAYLAND TRANSFER STATION CAPITAL PROJECT INTO THE LEACHATE FACILITY SCADA SYSTEM REPLACEMENT PROJECT MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

B. *Contract with Cooper Tank Recycling* – Mr. Spagnoletti requested authorization to contract with Cooper Tank Recycling for one year for them to provide two loads per day of processed construction and demolition debris at a rate of \$15.00 per ton.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO CONTRACT WITH COOPER TANK RECYCLING FOR ONE YEAR FOR THEM TO PROVIDE THE LANDFILL WITH TWO LOADS PER DAY OF PROCESSED CONSTRUCTION AND DEMOLITION DEBRIS AT A RATE OF \$15.00 PER TON MADE BY MR. MALTER. SECONDED BY MR. MULLEN. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

IV. **HIGHWAYS**

A. *Canisteo River Bridge, CR 66, Hornellsville* – Mr. Spagnoletti informed the committee that the new funding for federal aid highway bridges is 80 percent Federal and 20 percent State. There is no longer a local share for these bridges. He requested authorization to enter into an agreement with the New York State Department of Transportation for the funding of the design for the CR 66 bridge, along with small right-of-way incidentals. He also requested authorization to transfer \$50,000 from the Future Bridge Projects account to the CR 66 Bridge account. Mr. Spagnoletti explained we have to pay the bills up front, but then will be reimbursed 100 percent.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO ENTER INTO AN AGREEMENT WITH THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION TO PROVIDE FUNDING FOR THE DESIGN OF THE CR 66, CANISTEO RIVER BRIDGE IN HORNELLSVILLE, AND AUTHORIZING A TRANSFER OF \$50,000 FROM THE FUTURE BRIDGE PROJECTS CAPITAL PROJECT TO THE CR 66 CANISTEO RIVER BRIDGE CAPITAL PROJECT MADE BY MR. MALTER. SECONDED BY MR. MULLEN. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

B. *Engineering Aide* – Mr. Spagnoletti informed the committee that he has a zero-based Grade IX Engineering Aide position. He requested authorization to fund that position using a vacant funded Laborer position. Mr. Wheeler commented since this is an existing position, he is authorized in the Administrative Code to approve this.

C. *Appropriating Grinder Revenue* – Mr. Spagnoletti requested authorization to appropriate \$150,709.85 from Grinder Revenue into the Grinder Repair and Replacement Capital Project. He explained they rent the grinder to various municipalities that request it. In 2016 they rented it to Chemung County and the Towns of Bath, Rathbone and Pulteney. He noted that they currently have \$389.00 in the Grinder Repair and Replacement Capital Project. We use that money to purchase any necessary equipment to repair the grinder, such as the teeth.

Mr. Mullen asked haven't we transferred over \$300,000 into this account over the past few years? Mr. Spagnoletti replied that he does not have the numbers with him, but we do use the money for repairs to the machine. Mr. Mullen stated he does not mind voting for this if the account is low. When we originally purchased the grinder, you said there would be additional money from rentals that would go into the general fund. Then we purchased the machine and it was changed to going into a capital account. He thought we would be adding money to the equipment budget and did not realize how expensive it would be to maintain the machine. Is all of the money going to straight maintenance?

Mr. Miller replied all of the teeth and wear parts were worn out grinding our roads. It is an expensive machine to run. The rental money is being used to purchase all of the parts we are wearing out doing our roads. Mr. Mullen asked are you actually spending \$150,000 on parts? Mr. Miller replied we are probably spending about \$80,000.

Mr. Spagnoletti stated all of the revenues from the rental are paying for the repair costs of this machine. If we had not purchased the machine and instead rented one, we would have been \$380,000 behind. Purchasing the machine has saved us that money. With the transfer of \$150,000, we do not believe that we will use all of that to purchase parts, so there should be a surplus at the end of 2017.

Mr. Van Etten asked what percentage is the machine rented out? Mr. Spagnoletti replied we used it 25 days, Chemung County used it 23 days, and the Town of Bath, Rathbone and Pulteney each used it for one day. Mr. Van Etten asked we are only using it for a total of 60 days? Mr. Spagnoletti replied yes. It is about 50 days and when we send the machine, we also send an operator and a ground person. This money is only to be used for the repairs and maintenance of the machine. Discussion followed.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO APPROPRIATE \$150,709.85 IN 2016 GRINDER REVENUE INTO THE GRINDER REPAIR AND REPLACEMENT CAPITAL PROJECT MADE BY MR. MALTER. SECONDED BY MR. MULLEN. MOTION FAILS 2-1. (MR. MULLEN OPPOSED)

V. PARKS

A. *Non-Smoking Policy* – Mr. Spagnoletti introduced Lorelei Wagner from Public Health and Sarah Robbins from the Southern Tier Tobacco Awareness Coalition. They are here to discuss smoking at the parks. We are proposing to institute a non-smoking policy at the County parks, specific to the picnic pavilions, toilet buildings and playgrounds. This would include tobacco chewing or e-cigarettes.

Mr. Malter asked what is the buffer zone? Mr. Spagnoletti replied probably 100 feet. Mrs. Lando asked how will you enforce it? Mr. Bailey commented that we have campsites that are 100 feet from the playground areas. Mr. Wheeler stated in his view, you could put up the “No Smoking or Tobacco Beyond This Point” signs. Those do a pretty good job of deterring individuals. Mr. Spagnoletti stated we have a full-time staff person at Kanakadea Park and they would be able to monitor. Mr. Wheeler stated these policies usually become self-policing.

Mr. Van Etten asked what would be the penalty for smoking? Mr. Spagnoletti replied he would assume that we would ask them to stop and if they did not, then call the Sheriff. Mr. Mullen commented that he would like to look at the policy and then we could vote on it. Mr. Wheeler stated we can identify a process for that. He would shy away from a fine, as that would require a Local Law. He would think that we would issue a warning. At the County Office Building, we use cards that STTAC has given us and we hand those to individuals who are smoking in non-designated areas. Ms. Robbins stated that STTAC has non-confrontational cards that can be distributed. We also have signs and youth oriented signs.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO INSTITUTE A NON-SMOKING POLICY AT PICNIC PAVILIONS, TOILET BUILDINGS AND PLAYGROUNDS AT ALL COUNTY PARKS, SUBJECT TO THE APPROVAL OF THE FULL LEGISLATURE MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0. Resolution Required.

VI. BIDS

A. *Heavy-Duty Ten Wheel Trucks* – Mr. Spagnoletti recommended awarding the automatic and standard transmission to Kenworth #3. He noted the low bidder, Fleet Maintenance, Inc., did not meet the bid specifications. We will be purchasing three automatic trucks and we also are awarding the standard transmission to allow for any municipalities that want to piggyback off this bid.

Mr. Mullen noted many of the other bidders included a five-year warranty, and they were only slightly higher in price. Maybe that is something we could look at next time? Mr. Miller replied those five-year warranties are on minimal things that never go bad.

Mr. Hanna asked long-term, does this complete our replacement inventory? Mr. Spagnoletti replied no, this is an ongoing process. This year we will be getting rid of the 1997 trucks that are twenty years old. Mr. Hanna asked will you be replacing with these ten-wheel trucks? Mr. Spagnoletti replied Mr. Miller will decide which trucks are the worst. If they are side dump beds, then we will replace with these ten-wheel trucks as they are also side dump. Next year we will most likely replace the back dump trucks. Our recommendation at that time will be to replace with tri-axles, as they carry 50 percent more, for the same cost.

MOTION: DECLARING THE LOW BIDDER, FLEET MAINTENANCE, INC. AS NON-RESPONSIVE, AND AWARDING THE BID FOR HEAVY-DUTY TEN WHEEL TRUCKS TO KENWORTH #3 FOR \$219,409 PER UNIT FOR AUTOMATIC TRANSMISSION AND \$207,004 PER UNIT FOR STANDARD TRANSMISSION MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

B. *Reinforcing Steel Bars*

MOTION: AWARDING THE BID FOR REINFORCING STEEL BARS TO THE LOW BIDDER, CHEMUNG SUPPLY CORP. FOR A TOTAL PRICE OF \$53,082 MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

C. *Removal and Lawful Disposal of Deer Carcass(es)*

MOTION: AWARDING THE BID FOR THE REMOVAL AND LAWFUL DISPOSAL OF DEER CARCASS(ES) TO SIMONSEN ENTERPRISES FOR A PRICE OF \$30.00 PER UNIT FOR THREE YEARS MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

D. *Heavy Steel Pipe and Boiler Shells*

MOTION: AWARDING THE BID FOR HEAVY STEEL PIPE AND BOILER SHELLS TO THE FOLLOWING BIDDERS ON A LINE ITEM BASIS: ALLEGANY PIPE & TUBULAR PRODUCTS; AND CHEMUNG SUPPLY CORP., MADE BY MR. MALTER. SECONDED BY MR. MULLEN. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

E. *Removal/Recycle Fluorescent Bulbs* – Mr. Spagnoletti recommended extending the bid for 2017-2018 with Heritage-Crystal Clean, LLC.

MOTION: EXTENDING THE BID FOR THE REMOVAL & RECYCLING OF FLUORESCENT BULBS AWARDED TO HERITAGE-CRYSTAL CLEAN, LLC, FOR ONE YEAR, TERM TO COMMENCE 2/10/17 AND END 2/9/18 MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

I. CALL TO ORDER

Mr. Roush called the meeting to order at 9:45 a.m.

II. GENERAL BUSINESS

A. **Appropriating 2016 Grinder Revenue into Grinder Repair & Replacement Capital Project** – Mr. Spagnoletti informed the committee that they purchased the grinder in 2013. In the four years that they have owned the grinder, they have saved \$379,000 versus had they rented it. In 2016 we received \$150,000 and he requested authorization to transfer that to the Grinder Repair & Replacement Capital Project to pay for current and future bills. We have a current bill of \$21,000 to pay as well as \$10,000 for 2017 for repairs and the purchase of new teeth.

Mr. Farrand asked how many hours are on the machine? Mr. Spagnoletti replied he does not know the number of hours, but the machine was used 51 days last year. Mr. Farrand commented we need to think about the trade-in value for a newer machine. Mr. Spagnoletti stated if we are only using the machine for 50 days per year, he believes this machine will last at least another 15 years. We may not have to replace the machine. Mr. Farrand stated that he finds that hard to believe. Some of that rental revenue should be put aside to replace the current machine. Mr. Spagnoletti replied that is what the capital project is for.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO APPROPRIATE 2016 GRINDER REVENUE IN THE AMOUNT OF \$150,709.85 INTO THE GRINDER REPAIR & REPLACEMENT CAPITAL PROJECT MADE BY MR. NICHOLS. SECONDED BY MR. MALTER FOR DISCUSSION.

Mr. Mullen stated that he has no problem with using the money for repairs, but he does not want to put money in for the purchase of a new machine. In 2011, we started talking about this and it was said that we would rent the machine to Chemung County which would save money and generate \$105,000 in revenue. He stated he always thought the revenue would be coming back into the General Fund. We bonded \$800,000 - \$900,000 and it's like taking that money and shifting it. He has no problem with setting aside money to maintain the machine.

Mr. Wheeler stated there was a lot of discussion. If we put the money in a capital project, you could always transfer from that project. In a couple of years, if you decide not to let the project build up, you could then appropriate that money to something else. He stated that he personally likes putting funds into capital projects rather than accumulating it in the General Fund Balance. When it is project specific, it gives you some flexibility. You are not spending, but just accumulating.

Mr. Malter asked this is a capital project for the grinder? Mr. Wheeler replied yes. Mr. Spagnoletti stated he is just letting the committee know that the grinder will last at least twenty years. We will have just about all of the roads in the County ground, and we may not need to purchase another grinder, however, we will need to repair it.

Mr. Nichols commented the grinder has taken us to a whole new level from where we were when he first came on the Board in 2000. Back then, we were just leveling roads. We have been able to cover more roads with less money by grinding.

I. CALL TO ORDER

Mr. Roush called the meeting to order at 10:00 a.m. and asked Mr. Malter to lead the Pledge of Allegiance.

II. APPROVAL OF MINUTES

MOTION: APPROVING THE MINUTES OF THE JANUARY 9, 2016, AND JANUARY 23, 2016, MEETINGS MADE BY MR. MALTER. SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

III. LANDFILLS

A. *Town Roadside Cleanup Weeks* – Mr. Spagnoletti requested authorization to continue the town roadside cleanup weeks. He stated in 2016, ten towns participated. They brought in a total of 37 tons of garbage, 21 tons of tires and 2 tons of e-waste. The cost to the County was approximately \$6,000.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO CONTINUE TOWN ROADSIDE CLEANUP WEEKS MADE BY MR. NICHOLS. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

B. *Add Security Cameras to 2017 Major Equipment List* – Mr. Spagnoletti requested authorization to purchase security cameras for each pit at the Landfill and the three transfer stations. These cameras would provide a real-time feed to the scale house and records. We have four locations and the total cost is \$20,000.

Mr. Wheeler commented this is something we have been discussing for well over a year. This will provide another layer of security measures. Mr. Van Etten asked why are we putting the monitors at the scale houses? Mr. Wheeler replied there is always someone in the scale house, and there is not always someone in the room at the pit. Mr. Malter asked what would be the cost to put monitors in both the scale houses and the office at the pit? Mr. Wheeler replied he is not sure, but in his personal opinion, we will be fine having them at the scale house.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO PURCHASE FOUR SECURITY CAMERAS FOR EACH PIT AT THE BATH LANDFILL, HORNELL TRANSFER STATION, ERWIN TRANSFER STATION AND WAYLAND TRANSFER STATION, FOR A TOTAL COST OF \$20,000, AND AMENDING THE LANDFILL MAJOR EQUIPMENT LIST TO REFLECT THIS CHANGE MADE BY MR. NICHOLS. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 3-0.

IV. HIGHWAYS

A. *Agreement for Crusher with Four Towns* – Mr. Spagnoletti informed the committee that they have a shared services agreement with the Towns of Jasper, Tuscarora, Cameron and Woodhull, for the use of a gravel crusher. The original agreement was started between the four towns and we joined in 2007. This has been a good operation where we supply the repairs and send an operator and pit foreman with the machine. We also carry the ID number and the insurance. Over the last couple of years the machine has been breaking down and is becoming an inefficient operation for us.

Mr. Spagnoletti presented four options for the committee to review; continuing to crush our own, renting for one month, subcontracting or purchasing gravel FOB from a vendor. The per ton cost for crushing ourselves is \$5.76; to rent a machine for one month is \$2.44; to subcontract is \$3.47 and to purchase from a vendor is \$8.33. The current cost for us to crush using the crusher with the towns is \$463,000. If we were to rent a machine for one month and subcontract, the total cost would be \$278,000.

Mr. Malter asked is the crusher owned by the four towns and the County? Mr. Spagnoletti replied yes, we bought into it in 2007. We pay \$4,000 for two weeks of rental and pay \$25.00 per hour for anything in addition to that. We also pay the predominant repair costs. There is a fund, between the towns and the County that has \$104,000. If we and the Town of Cameron back out of the agreement, that \$104,000 will remain in the fund for use by the two remaining towns.

Mr. Spagnoletti requested authorization to pull out of the contract with the towns. If the committee is in agreement, then later in the agenda, under bids he would recommend renting a machine for one month and subcontracting out.

Mr. Malter asked do the towns have their own gravel pits? Mr. Eggleston replied Jasper does not and we grind in their yard. Woodhull has a very small pit, but we grind in their yard. Tuscarora and Cameron each have their own pits. We move the equipment to where it is needed.

Mr. Spagnoletti commented if you agree to letting us pull out, then when we bid this out next year, we will ask the towns if they want to be included on the subcontract or rental bid. We would at least offer that as an option.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO TERMINATE THE AGREEMENT WITH THE TOWNS OF CAMERON, JASPER, TUSCARORA AND WOODHULL FOR THE USE OF A GRINDER MADE BY MR. MALTER. SECONDED BY MR. NICHOLS FOR DISCUSSION.

Mr. Malter stated that he is concerned about where this puts the towns. We currently send someone with the machine and that will be an added cost to the towns. Mr. Spagnoletti replied the towns operated the crusher for a number of years prior to us joining in. Mr. Malter asked where is the machine stored? Mr. Eggleston replied in the Town of Jasper.

Mr. Nichols asked with regard to MSHA requirements, will the towns need to hold the permits if they are no longer covered by the County? Mr. Eggleston replied someone will have to step up and take responsibility for the unit. Since some of the Town Highway Superintendents come and go, his recommendation would be that the Deputy Town Highway Superintendent take over the health and safety aspects of it.

Mr. Malter asked will each town have to have a permit and add it to their insurance? He stated his issue is the additional burden we are adding to the towns and we don't know what it will be. Maybe we could ask the towns to get rid of the machine and bid with them included. Mr. Spagnoletti stated when we talked with the towns, they said they would be fine if we left.

Mr. Nichols commented that he would have liked to see you come back to the towns before the bid went out. He commented that his Town Highway Superintendent never said anything. Mr. Roush commented this solves the problem long-term, but may create problems in the short-term. Mr. Spagnoletti stated the current bids are not structured to extend them to the towns.

Mr. Malter stated he has no problem getting out of the contract, he is just concerned about the towns. Mr. Nichols stated he hasn't had conversation with his Highway Superintendent. He would have felt more comfortable if the towns had been included in the bid, if they wanted to participate. I. CALL TO ORDER

Mr. Swackhamer called the meeting to order at 10:40 a.m. and lead the Pledge of Allegiance.

II. APPROVAL OF MINUTES

III. INTRODUCTION

Mr. Spagnoletti introduced Doug Rapalee who will be the new Deputy Commissioner of Public Works effective April 3, 2017.

IV. HIGHWAYS

A. *Grinder Rental Agreement* - Mr. Spagnoletti requested authorization to extend the grinder rental agreements with Schuyler and Yates counties for three years. The current cost to Schuyler and Yates counties is \$4,000 per day and we provide the operator and ground person. The cost for the rental of the Zipper is \$1,000 per day. The price for 2017 and 2018 will stay at \$4,000 per day and will increase to \$4,200 per day for 2019. Our cost to rent is \$2,200 per day without fuel. Schuyler and Yates provide the fuel.

This project is 95 percent federal funding and 5 percent local share. He requested authorization to appropriate \$427,500 of the federal share to this project and appropriate \$22,500 County share from the Future Bridge Projects Account.

We took samples of policies from different counties. This is just a policy that does away with the use of all products near the buildings and playground. They will put up signs 15 feet away from those areas. Warnings will be provided, and if they are not compliant, then an individual’s ability to come to the park may be revoked.

Mr. Wheeler commented the proposal before you is a good compromise. As with the County Office Building, we can revoke the license of someone to be on our premises. This really will be self-policing.

In the beginning we offered these at no charge, but then started charging. Now they are requesting access to this equipment again. Mr. Mullen asked if we send staff, does that affect our operations? Mr. Spagnoletti replied it will have some impact as renting out this additional equipment with operators would require four extra people. Mr. Mullen stated his primary concern is about the grader. Mr. Spagnoletti stated we have other graders we can use and this agreement will not prevent us from doing our work.

Mr. Malter stated his only concern is the useful life of the equipment will be depleted. If the money from the rental is going into a capital project to replace the equipment, he would not have a problem with that. Mr. Spagnoletti replied he believes the money will go into the revenue line item and that ultimately ends up in the machinery fund. Mr. Wheeler stated you can appropriate the revenue however you choose.

Mr. Malter stated he does not want it to be used for additional revenue for the highway department. The money should go to the machinery fund for a capital project. Mr. Wheeler stated if it is in the machinery fund, we track that spending. We can establish a capital project or cap and that is used year to year.

Mr. Van Etten commented the machinery fund is an operating fund, not a capital fund. Mr. Malter asked do we have a capital project for machinery purchases? Mr. Wheeler replied not specifically. Mr. Mullen stated that he does not think it will create a lot of additional use of the equipment. Mr. Malter stated we don't know that. Mr. Spagnoletti stated last year they used the grinder 20 – 25 days. Mr. Mullen stated we will not be creating additional use as we would be using it anyway. Mr. Spagnoletti stated the grader and water truck would be used for 3 – 4 weeks. Mr. Malter asked what is the projected revenue? Mr. Spagnoletti replied last year we received \$43,000 and without the labor it would have been \$20,000. Mr. Malter stated that he will withdraw his objection.

VOTE ON PREVIOUS MOTION: ALL BEING IN FAVOR. MOTION CARRIES 5-0.

B. *Design Agreement with Popli Engineers* – Mr. Spagnoletti informed the committee they will be doing a Federal aid bridge project on CR 66 in the Town of Hornellsville. This is a \$3 million project that will be built in 2020. He requested authorization to enter into a design agreement with Popli Engineers for \$270,000. This will be paid for by State and Federal funding.

C. *Design Agreement with Fisher Engineers* – Mr. Spagnoletti informed the committee that they will be doing a Federal aid bridge project on CR 22 in the Town of Cameron. This is a \$3.5 million project that will be built in 2019. He requested authorization to enter into a design agreement with Fisher Engineers for \$362,000. The Federal portion is 95 percent; the County’s portion is 5 percent, which will be \$18,100.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO ENTER INTO A DESIGN AGREEMENT WITH FISHER ENGINEERS FOR \$362,000, WITH A COUNTY SHARE OF \$18,100 FOR THE CONSTRUCTION OF THE CR 22 BRIDGE IN THE TOWN OF CAMERON MADE BY MR. NICHOLS. SECONDED BY MR. ROUSH. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

D. *CR 119 Addison Easement Request* – Mr. Spagnoletti informed the committee that the Eagle Hotel was built on our right-of-way. He would like to allow them permission to encroach on our property so that they can sell the building, at which time we will allow an easement.

Ms. Prossick commented this was a State road until 1998 when it was handed over to the County. The building was built in the 1850’s and the second story balcony encroaches on our right-of-way. We need to spell out the terms for completing the paperwork. Mr. Mullen stated he will be abstaining, as he is an attorney with the firm that is handling this.

Mr. Swackhamer asked will an easement create a possible problem down the road if we release it to the landowner? Ms. Prossick stated you could do a release. It’s the second story balcony that is in the right-of-way air space. She stated she would prefer to do a straight easement, or you could do a boundary line agreement.

Mr. Nichols asked is there a possibility, as long as the building exists how it is, to allow it to be on our right-of-way; however, if they build onto it, then we go back to the original right-of-way? Ms. Prossick stated that would be a boundary line agreement. Mr. Nichols stated to him, that makes more sense and he would rather see the boundary line agreement. Mr. Malter stated he agrees.

I. CALL TO ORDER

Mr. Swackhamer called the meeting to order at 10:00 a.m. and asked Mr. Malter to lead the Pledge of Allegiance.

II. APPROVAL OF MINUTES

Mr. Mullen stated he does not have any corrections; however, he does have a question for Mr. Spagnoletti. With regard to the hazardous waste bid, the \$24,000 award we made, is it a set fee or based on volume collected? Mr. Spagnoletti replied it is volume driven.

MOTION: APPROVING THE MINUTES OF THE APRIL 3, 2017, MEETING MADE BY MR. MALTER. SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 4-0.

III. HIGHWAYS

A. *Shared Services Summary* – Mr. Spagnoletti provided a summary of their shared services program. This information is available on the Public Works Department page on the County Website. There are numerous shared services they participate in, however, there are a few in particular that he would like to mention:

- *Shared Use of Equipment – Fuel Tank System* – Mr. Spagnoletti stated the installation of the fuel tank system cost the County \$630,000. We charge \$0.13 per gallon to other departments and municipalities which has resulted in a savings across the County.
- *Salt Storage Buildings* – We help with the construction of salt storage buildings and pay one-quarter to one-half of the cost. There are salt storage buildings in Pulteney, Thurston, Urbana and Wayne. The county has spent approximately \$200,000 and these are mostly utilized by the towns.

- **Precast Box Culverts** – Mr. Spagnoletti stated they make these for the towns at 40 percent less cost than if they purchased them from a vendor on bid. We also install them. Mr. Farrand commented this is a great program and he would like to note that the towns do provide assistance.
- **Bridges** - We design, build and maintain 142 town bridges. The towns maintain the approaches to the bridges, as well as the driving surface of the bridge. This is a \$50 million asset that the County is carrying for the towns and you are putting \$800,000 into the County budget to take care of those bridges.

Mr. Hauryski commented the Governor has required each county to hold meetings of a shared services panel. This week we will be holding our first meeting. What we have already included previously under shared services cannot be included in the new plan. Look at the volume of the shared services we do just with the Department of Public Works. Mr. Wheeler stated the way they have defined shared services in the past is if it is something that stops every year. Shared equipment with municipalities; in his view, each year that is new. With the bridges, you might be able to include the new ones that are coming up. He thinks we should take credit for it.

Mrs. Ferratella asked do we benchmark with other counties to see if they are doing similar things? Mr. Spagnoletti replied he does not have the figures on that. Mr. Wheeler replied it depends on how you measure it. If you measure the amount of equipment shared, that would be more accurate than measuring the additives. We will have the ability to see the shared services plans of other counties and we may be able to benchmark things better once those plans come out.

B. *Transfer of Property – Town of Caton* – Mr. Spagnoletti requested authorization to transfer a parcel of .83 acres from the Town of Caton to the County for \$1.00, so that we can build our new highway shop. With your approval, we would like to do the site work this year and do as much of the construction as we can with our own crews.

Mr. Maio commented that he is the Caton Town Attorney. They will be holding their Town Board meeting on the 2nd Wednesday. At that time, we will need to see if this is subject to a permissive referendum on the town side. If so, this transfer would not be effective for 30 days. The Town Board is in favor of this transfer.

MOTION: AUTHORIZING THE TRANSFER OF A PARCEL OF .83 ACRES FROM THE TOWN OF CATON TO THE COUNTY OF STEUBEN FOR \$1.00 FOR THE NEW HIGHWAY SHOP MADE BY MR. MALTER. SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 4-0. Resolution Required.

He requested authorization to accept the grant and appropriate the funding to the Public Works Major Equipment line, and amend the Major Equipment list.

He requested authorization to solicit requests for proposals for a private firm to do that research for us. We just do not have the staff available to do it. This is just for the mark outs.

C. *Kanakadea Park Cabins* – Mr. Spagnoletti stated last month Mr. Malter had asked about the cabins at the park. Klipnocky had put in four cabins to rent and one office cabin. The cabins were very popular. Klipnocky removed the cabins, so last year, 2016, we used some funds to construct an office cabin and this year we are going to use about

\$7,000 to build one rental cabin. Additionally, in the past we have used wood picnic tables. We are now making them out of metal pipe frames. The wood tables cost \$100 and the metal pipe frame tables are \$200. We will plan to make 10 tables per year.

Mr. Malter asked is it your intention to build more cabins? Mr. Spagnoletti replied he does not know at this point. He would like to wait and see what we get in revenues from the rental. Mr. Farrand commented the building trades program at BOCES are always looking to do a couple of projects.

A. *Leachate Fees* – Mr. Spagnoletti informed the committee that currently they charge \$9.00 per ton for leachate. He requested authorization to increase that rate to \$10.00 per ton. Additionally, he would also like to create two categories; normal leachate and high strength leachate. He proposed charging \$10.00 per ton for normal leachate and \$15.00 per ton for high strength leachate. Mr. Wheeler asked how will you differentiate between the two? Mr. Spagnoletti replied they will define the strengths.

Mr. Van Etten asked will increasing the rate cause the haulers to not want to bring leachate to us? Mr. Spagnoletti replied it may. Mr. Wheeler commented the increase in fees will be used for upgrades that will need to be made in the near future.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO INCREASE THE FEES FOR LEACHATE FROM \$9.00 PER TON TO \$10.00 PER TON AND TO CREATE TWO CATEGORIES OF LEACHATE; NORMAL STRENGTH AT \$10.00 PER TON AND HIGH STRENGTH AT \$15.00 PER TON MADE BY MR. ROUSH. SECONDED BY MR. MULLEN. ALL BEING IN FAVOR. MOTION CARRIES 5-0. Resolution Required.

B. *Household Hazardous Waste Grant* – Mr. Spagnoletti requested authorization to apply for and once received, accept a Household Hazardous Waste Grant. The State will pay half of the cost for the household hazardous waste collection dates we hold at the transfer stations. The cost to hold those events is \$30,000 and the grant will pay \$15,000.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO APPLY FOR, AND ONCE RECEIVED, ACCEPT A HOUSEHOLD HAZARDOUS WASTE GRANT IN THE AMOUNT OF \$15,000 MADE BY MR. MULTER. SECONDED BY MR. MULLEN. ALL BEING IN FAVOR. MOTION CARRIES 5-0. Resolution Required.

C. *Barton & Loguidice Authorization to Design, Bid and Administer Cell 4 Construction* – Mr. Spagnoletti informed the committee that currently they are using Cell 3 and anticipate the cell will be at full capacity in 2019. He requested authorization to contract with Barton & Loguidice to design, bid and administer the construction of Cell 4 to be constructed in 2018. The proposal from Barton & Loguidice is \$290,200.

Mr. Swackhamer asked why are we paying for the design? Mr. Spagnoletti stated the design portion is \$72,000. Mr. Swackhamer stated it is the same thing that we just designed. Mr. Spagnoletti explained the new cell is laying on different land, there are different elevations. Mr. Wheeler commented they will need to stamp it. If we bid it to challenge the price, we may end up paying more. Mr. Spagnoletti stated this is a \$6 million project to build and this proposal to design, bid and administer is very low.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO CONTRACT WITH BARTON & LOGUIDICE TO DESIGN, BID AND ADMINISTER THE CONSTRUCTION OF CELL 4 FOR A TOTAL COST OF \$290,200 MADE BY MR. MULLEN. SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

IV. HIGHWAYS

A. *Reclassification* – Mr. Spagnoletti requested authorization to reclassify a vacant Account Clerk-Typist position, Grade VI, to a Typist, Grade IV. He explained that Deb Cotter previously held the position working for him, but is now doing payroll and bids. He commented that he really only needs a Typist.

MOTION: AUTHORIZING THE RECLASSIFICATION OF A VACANT ACCOUNT CLERK-TYPIST POSITION, GRADE VI, TO A TYPIST, GRADE IV MADE BY MR. MULLEN. SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

B. *Convey Excess County ROW on CR 66 to Adjacent Landowner* – Mr. Spagnoletti requested authorization to grant a permanent easement for the County's right-of-way on CR 66 adjacent to Simmons-Rockwell. This is a parcel that is 24 feet by 183 feet. Ms. Prossick explained the State originally gave it to the County for maintenance purposes. Mr. Wheeler stated this property is across the street from the Ford shop and Simmons-Rockwell would like to use it for parking of vehicles.

MOTION: GRANTING A PERMANENT EASEMENT ON THE COUNTY'S RIGHT-OF-WAY ON CR 66 TO THE ADJACENT PROPERTY OWNER, SIMMONS-ROCKWELL MADE BY MR. ROUSH. SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

C. *Transfer Wilson Hollow Bridge from Town of Hornby to Steuben County* – Mr. Spagnoletti informed the committee in 1998 the County took over the last 8 remaining bridges longer than 25 feet from the towns. We take care of all 142 bridges that are longer than 25 feet on town roads, as the towns do not have the engineering staff. He requested authorization to transfer the Wilson Hollow Bridge from the Town of Hornby to the County. The Town of Hornby will pay for one-half of the material costs to build the new bridge. Additionally, if we can put in a box culvert they will pay for one-half the cost of that. If the bridge then becomes shorter than 25 feet, ownership will revert back to the town. Mr. Swackhamer asked what is the projected cost? Mr. Spagnoletti replied \$150,000. Currently the bridge is 31 feet long.

MOTION: TRANSFERRING THE WILSON HOLLOW BRIDGE FROM THE TOWN OF HORNBY TO STEUBEN COUNTY MADE BY MR. MALTER. SECONDED BY MR. MULLEN. ALL BEING IN FAVOR. MOTION CARRIES 5-0. Resolution Required.

V. **PARKS**

A. *Birdseye Hollow Park* – Mr. Spagnoletti requested authorization to transfer the parking, pavilion and playground areas of Birdseye Hollow Park from the NYS Department of Environmental Conservation to the County. This constitutes about 6.75 acres of the park and will make it easier for us to operate.

Mr. Malter asked are we generating any revenue at this park? Mr. Spagnoletti replied no. The only park that generates revenue is Kanakadea due to the camping. Mr. Malter asked will it cost us more money to own those areas? Mr. Spagnoletti replied no, it will make it easier for us to operate the park. Mr. Malter asked what is the annual cost to run the park? Mr. Spagnoletti replied he has two individuals who take care of the parks all year. The only costs are repairs to the pavilion, which are minimal. Also, the Mobile Work Program helps clean up the parks, pick up litter and take care of the trails.

MOTION: AUTHORIZING THE TRANSFER OF THE PARKING, PAVILION AND PLAYGROUND AREAS OF BIRDSEYE HOLLOW PARK FROM THE NYS DEPARTMENT OF ENVIRONMENTAL CONSERVATION TO STEUBEN COUNTY MADE BY MR. NICHOLS. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 5-0. Resolution Required.

VI. **BIDS**

A. *Fiber Optic Cable Location Services* – Mr. Morse stated we did not get any responses to the RFP we sent out. We did poll the potential vendors and one of the biggest issues for not responding was prevailing wages. Another vendor indicated that they did not have time for this type of project. Mr. Morse stated he did talk to the Department of Labor who indicated that he could take the prevailing wages portion out of the RFP. Mr. Wheeler commented we currently do this in-house, but need to bid this due to our limitations.

VI. **OTHER BUSINESS**

A. *Used Landfill Compactor* – Mr. Spagnoletti indicated that Allegany County will no longer be operating a landfill, and have offered to us the purchase of a used landfill compactor for \$10,000. He requested authorization to purchase and add to the Landfill's Major Equipment list.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO PURCHASE A USED LANDFILL COMPACTOR FOR \$10,000 FROM ALLEGANY COUNTY AND TO AMEND THE LANDFILL MAJOR EQUIPMENT LIST TO REFLECT THIS PURCHASE MADE BY MR. MULLEN. SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

Mr. Mullen recused himself from discussion and left the meeting.

VII. **HIGHWAYS (Cont.)**

D. *Call Hill Easement* – Mr. Spagnoletti informed the committee of a final proposal to obtain access to our landlocked parcel at Call Hill. Discussion followed.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO OFFER \$4,000 TO MULLEN AND \$3,000 TO WHYTE/TOWNSEND FOR ACCESS TO THE RIGHT-OF-WAY TO THE CALL HILL PROPERTY MADE BY MR. ROUSH. SECONDED BY MR. MALTER. MOTION CARRIES 3-1. (MR. SWACKHAMER OPPOSED, MR. MULLEN WAS A RECUSAL)

MOTION: TO AJDOURN MADE BY MR. MALTER. SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 4-0. (MR. MULLEN ABSENT FOR VOTE)

I. CALL TO ORDER

Mr. Swackhamer called the meeting to order at 10:00 a.m. and asked Mr. Nichols to lead the Pledge of Allegiance.

II. APPROVAL OF MINUTES

MOTION: APPROVING THE MINUTES OF THE JUNE 5, 2017 MEETING MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

III. LANDFILLS

A. *Capital Project for Cell 4* – Mr. Spagnoletti informed the committee that Cell 3 in the Landfill will be full by the end of 2019 and we will begin building Cell 4 in 2018. The new cell will cost between \$6 million and \$6.5 million. We have \$1,472,000 remaining in the capital project for Cell 3 and he requested authorization to transfer that amount into a new capital project for Cell 4.

MOTION: AUTHORIZING THE CREATION OF A NEW CAPITAL PROJECT FOR THE LANDFILL CELL 4 CONSTRUCTION AND TRANSFERRING SURPLUS FUNDS FROM THE CELL 3 CAPITAL PROJECT IN THE AMOUNT OF \$1,472,000 INTO THE CELL 4 CAPITAL PROJECT MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

B. *Leachate Tank Restoration* – Mr. Spagnoletti requested authorization to award the bid for Leachate Tank Restoration to PIM Corporation for a total cost of \$109,585.

MOTION: AWARDING THE BID FOR LEACHATE TANK RESTORATION TO PIM CORPORATION FOR A TOTAL COST OF \$109,585.00 MADE BY MR. NICHOLS. SECONDED BY MR. ROUSH. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

IV. HIGHWAYS

A. *CR 69 Property* – Mr. Spagnoletti requested authorization to return 1.631 acres on CR 69 in the Town of Howard to the Faucett family.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO TRANSFER OF 1.631 ACRES ON CR 69 IN THE TOWN OF HOWARD TO G. & S. FAUCETT MADE BY MR. MALTER. SECONDED BY MR. ROUSH. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

B. *Purchase Loader off Cattaraugus County Bid* – Mr. Spagnoletti requested authorization to purchase a Hyundai 960L, 4.25 cy bucket loader with scale for \$180,000 off the Cattaraugus County bid.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO PURCHASE A HYUNDAI 960L, 4.25 CY BUCKET LOADER WITH SCALE FOR \$180,000 OFF THE CATTARAUGUS COUNTY BID MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

C. *Authorization to Sell Conrad's Gravel Pit* – Mr. Spagnoletti informed the committee that back in 1975 the County purchased Conrad's Gravel Pit in Bath for \$75,000. That pit had good gravel and is now pretty well cleaned out and is down to sand with very little gravel. He stated that he would like to sell the pit, which is on 47.42 acres, along with a secondary parcel of 9.69 acres which a portion of the Finger Lakes trail goes through. He would like to put it up for sale as two separate transactions and keep a provision of having an easement on the second parcel for the Finger Lakes Trail.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO SELL CONRAD'S GRAVEL PIT IN BATH, CONSISTING OF 47.42 ACRES AND 9.69 OF ADJOINING PROPERTY WITH A STIPULATION THAT AN EASEMENT WILL REMAIN ON THE 9.69 PARCEL FOR THE FINGER LAKES TRAIL MADE BY MR. ROUSH. SECONDED BY MR. MALTER. MOTION CARRIES 4-0-1. (MR. MULLEN ABSTAINED AS HE IS THE ATTORNEY FOR THE FINGER LAKES TRAIL)

Mr. Malter asked is there an expense for the closure of the pit? Mr. Spagnoletti replied yes, if we retained the pit, we would be responsible for the reclamation costs. Ms. Prossick replied we will need to include wording that if it is not purchased by another gravel pit owner, then the new owner will need to be able to do the reclamation.

D. *Road Projects* – Mr. Spagnoletti requested authorization to transfer a total of \$703,000 from various road projects into the Permanent Improvements Capital Project to add the following projects – CR 36 – Cohocton, CR 16/20 - Bradford, CR 17 – Campbell, CR 4 – Campbell and CR 42 – Hornby.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO TRANSFER \$703,000 FROM VARIOUS ROAD PROJECTS INTO THE PERMANENT IMPROVEMENTS CAPITAL PROJECT AND ADD THE FOLLOWING PROJECTS: CR 36 – COHOCTON, CR 16/20 – BRADFORD, CR 17 – CAMPBELL, CR 4 – CAMPBELL AND CR 42 – HORNBY MADE BY MR. ROUSH. SECONDED BY MR. NICHOLS.

V. **OTHER BUSINESS**

A. *Road Projects* - Mr. Spagnoletti provided an update on the status of this year's road projects.

B. *Box Culverts* – Mr. Spagnoletti stated that every year we build and install one or two box culverts for the towns. Mr. Catherman looked at our cost to build and install these box culverts and it is \$190,000. We looked at two larger neighboring counties that hire a consultant engineer to design and build their box culverts, and it costs them \$470,000.

C. *Mobile Work Program* – Mr. Spagnoletti announced one of the Mobile Work crews has been working on the Shady Grove Wesleyan Church and are putting on new siding. Mr. Farrand asked is there any possibility of expanding the Mobile Work Program? Mr. Spagnoletti replied we currently have three people per crew. Mr. Wheeler stated we have one of the most aggressive Mobile Work Programs in the State. Ms. Fitzpatrick asked can we use these crews to pick up litter? Mr. Spagnoletti replied picking up roadside litter is one of the tasks that the crews do.

D. *Landfill Tour* – Mrs. Lando stated that she would like to thank Mr. Spagnoletti and the staff for the Landfill tour. It is amazing the work you do.

I. CALL TO ORDER

Mr. Swackhamer called the meeting to order and asked Mr. Roush to lead the Pledge of Allegiance.

II. APPROVAL OF MINUTES

MOTION: APPROVING THE MINUTES OF THE JULY 10, 2017, MEETING MADE BY MR. MALTER, SECONDED BY MR. NICHOLS. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

III. HIGHWAYS

A. *Property Transfer* – Mr. Spagnoletti stated last month he had requested authorization to transfer 1.631 acres of property on CR 69 to G. and S. Faucett. They have asked if the County will pay the survey and deed filing costs which will be up to \$1,500 for the survey and \$200 for the deed filing. We did not pay them for the property and the County has had ownership since 1980.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO PAY THE SURVEY AND DEED FILING FEES ASSOCIATED WITH THE TRANSFER OF 1.631 ACRES ON CR 69 TO G. & S. FAUCETT MADE BY MR. ROUSH. SECONDED BY MR. MALTER FOR DISCUSSION.

Mr. Mullen asked how did the County originally acquire the property? Mr. Spagnoletti replied they signed it over to us. Mr. Mullen stated that he does not know if he is in favor of paying the survey and filing fees. The price for doing that seems high. Mr. Malter asked with this property transfer does it enhance their property? Mr. Spagnoletti replied it is connected. He assumes they want to make sure the property lines are correct. Ms. Prossick commented this was a road frontage issue. Mr. Malter stated the addition of this property makes it more sellable. Why are we paying for something that will enhance their ability to sell?

Mr. Mullen asked what were the terms of the deal back in 1980? Mr. Spagnoletti replied he does not know. Ms. Prossick explained we cannot deed back this portion to them without a survey being done. Mr. Mullen stated he does not have an issue deeding to them, but he does not think the land is worth the price of the survey.

VOTE ON PREVIOUS MOTION: MOTION FAILS 1 – 4. (MR. SWACKHAMER, MR. MALTER, MR. MULLEN AND MR. NICHOLS OPPOSED.)

Mr. Nichols stated that he would be willing to split the difference with the property owner. Mr. Malter stated he would be in favor of a motion deeding the property over to them at no cost to the County. Mr. Spagnoletti stated the committee authorized that last month.

B. *Maintenance Jurisdiction from NYSDOT on SR 415 Town of Erwin* – Mr. Spagnoletti stated the Town of Erwin has requested that NYSDOT abandon the maintenance jurisdiction on a portion of SR 415 which is the entrance to the Erwin airport. He stated that NYSDOT rules require them to abandon to the County first. Mr. Spagnoletti requested authorization to accept the maintenance jurisdiction on a 6 acre parcel on SR 415 from NYSDOT and to convey to the Town of Erwin/Town of Erwin IDA. Mr. Mullen added that it is with the understanding that the Town of Erwin will be taking over the maintenance jurisdiction.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO ACCEPT MAINTENANCE JURISDICTION FROM NYSDOT FOR ~6 ACRE PARCEL ON SR 415 AND CONVEYING TO THE TOWN OF ERWIN/TOWN OF ERWIN IDA WITH THE UNDERSTANDING THAT UPON CONVEYANCE, THE TOWN OF ERWIN WILL TAKE OVER THE MAINTENANCE JURISDICTION MADE BY MR. MALTER. SECONDED BY MR. NICHOLS. MOTION CARRIES 4-0-1. (MR. ROUSH ABSTAINED, AS HE IS A MEMBER OF THE ERWIN TOWN BOARD). Resolution Required.

C. *Reagan Gravel Pit Lease* – Mr. Spagnoletti requested authorization to enter into a lease with the Reagan Gravel Pit. The lease is for a term of five years, effective September 17, 2017, at a rate of \$1.55 per cubic yard. The price has increased \$.10 from the previous agreement.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO ENTER INTO A LEASE AGREEMENT WITH REAGAN GRAVEL PIT IN RATHBONE FOR FIVE YEARS, AT A RATE OF \$1.55 PER CUBIC YARD MADE BY MR. MULLEN. SECONDED BY MR. ROUSH. ALL BEING IN FAVOR. MOTION CARRIES 5-0. Resolution Required.

D. *Seneca Road Bridge* – Mr. Spagnoletti requested authorization to close the Seneca Road Bridge Capital Project and transfer the remaining funds of \$103,183.80 into the Future Bridge Projects Capital Project.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO CLOSE THE SENECA ROAD BRIDGE PROJECT CAPITAL PROJECT AND TRANSFER THE REMAINING FUNDS OF \$103,183.80 INTO THE FUTURE BRIDGE PROJECTS CAPITAL PROJECT MADE BY MR. MALTER. SECONDED BY MR. MULLEN. ALL BEING IN FAVOR. MOTION CARRIES 5-0. Resolution Required.

E. *Budget Transfer to New Caton Shop Capital Project* – Mr. Spagnoletti informed the committee that the Caton Shop was originally built in 1926 and was demolished. He stated he has \$350,000 in a capital project for the construction of a new building. He requested authorization to transfer \$158,839.11 from various projects into the Capital Project entitled “Caton Shop Replacement”. Additionally it is anticipated that they will budget \$250,000 for this project in 2018. Mr. Spagnoletti stated the proposal from Hunt Engineers to build a 150’ x 90’ building will be in the range of \$800,000 to \$1,100,000. We have asked Hunt to design a six-bay building, but when we bid it, it will be for a four-bay building with the option to add two additional bays. The \$759,000 we will have in the capital project should cover the cost of a four-bay building. We will also see if we can do some of the site work with our bridge crew.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO TRANSFER A TOTAL OF \$158,839.11 FROM VARIOUS PROJECT ACCOUNTS INTO THE CAPITAL PROJECT ENTITLED “CATON SHOP REPLACEMENT” MADE BY MR. MALTER. SECONDED BY MR. NICHOLS FOR DISCUSSION.

Mr. Mullen asked do you currently have a shop or are you working with the Town of Caton? Mr. Spagnoletti replied no, we have an office trailer that the crew works out of. There is one building across the street with two bays that we store some things in. Additionally, we have a salt storage shed. Mr. Nichols asked do we have the land? Mr. Spagnoletti replied the Town of Caton is transferring 1 acre to allow us to extend the property to the north.

Mr. Nichols asked will this be a pre-engineered building? Mr. Spagnoletti replied yes, but we would still have to hire an engineer for the site prep and other related work. Ideally we would like to do a prefabricated building and we could do the site work with our crews.

Mr. Mullen stated that he would like to discuss the plan more and put out an RFP for the design work. Mr. Wheeler asked is the price estimate based on construction costs? Mr. Spagnoletti replied this building will be 9,000 square feet and the proposal is between \$800,000 to \$1,100,000. That would be for a six-bay building. Mr. Wheeler asked are you having them design a four-bay with the potential to build a six-bay? Mr. Spagnoletti replied the design is for a six-bay building and we will bid it as a four-bay building with the option to include two additional bays. Mr. Mullen asked why does it need to be engineered? Mr. Spagnoletti replied it has to be engineered even though it is prefabricated. Mr. Mullen stated he would like to see what other proposals would be. This proposal seems a little high. Mr. Spagnoletti stated Hunt Engineers has already been approved as the engineer for the County. Mr. Mullen commented we use other engineers such as Barton & Loguidice and LaBella.

Ms. Prossick stated you would have to go out for an RFP specific to this project as the proposal from Hunt was a countywide RFP. Mr. Wheeler explained the RFP for Hunt was mainly for the courthouse work and to enable us to piggyback for other projects. He does not disagree with Mr. Mullen as the proposal is 7.5 percent construction cost. We are paying Labella 7 percent for the complex new office building. The price seems pretty high.

VOTE ON PREVIOUS MOTION: ALL BEING IN FAVOR. MOTION CARRIES 5-0.

Mr. Malter asked if we are going to bid this, he assumes this will give us more time to compare to a prefabricated building with engineering included? Mr. Wheeler replied we cannot do a design build. The presumption is that a company comes in with a blank foundation and here is the building. Ms. Prossick commented you could do an alternative. Mr. Morse stated with the Wick's Law, anything over \$500,000 has to be bid.

Mr. Rapalee stated that he likes the idea of having Hunt do this as our Caton Shop crew has been without a shop for five years and our equipment is outside. If you award today, we can get a set of design documents by January, start construction by April or May and be ready to move in October. Another advantage is that it gives us the potential for future design and we will have documents that we own. Mr. Mullen stated we would have the documents regardless. He does not have a problem with the work that Hunt does. This is a large layout and he does agree that there is some urgency in getting it done.

Mr. Malter asked if we bid the engineering, how much of a delay would that be? Mr. Wheeler replied it would be two months. He would wait until you get the budget. It depends on the additional money coming into the 2018 budget. You could still put it out in January. Assuming the budget goes through, you will know by November what you have to work with. He stated that he likes Hunt and they do a fine job. This is a high construction cost, but again by bidding, you will know what competitive prices are. He would recommend bidding it. Mr. Malter commented if we do a new RFP, it will hold the process up two months, but you would not be doing anything until January anyway.

I. CALL TO ORDER

Mr. Swackhamer called the meeting to order at 10:00 a.m. and asked Mr. Nichols to lead the Pledge of Allegiance. Following the Pledge of Allegiance, Mr. Swackhamer asked for a moment of silence to remember the events of September 11, 2011, as well as the victims of Hurricanes Harvey and Irma.

II. APPROVAL OF MINUTES

III. HIGHWAYS

A. *Approval of Commissioner of Finance to do Accounting for Towns' Shared Services Crusher* – Mr. Spagnoletti stated that earlier this year we removed ourselves from the Shared Services Agreement for the use of the Crusher with four towns. The towns have asked if Mrs. Hurd-Harvey could continue to do the accounting for the Crusher. The towns will provide invoices with two signatures and Mrs. Hurd-Harvey will issue checks to the towns who will then pay the vendor. She would also keep track of the payments and balance in the account.

Mr. Mullen asked did we transfer the \$100,000 to the towns? Mr. Spagnoletti replied no, the money stays with the County and is paid to the towns. Mr. Wheeler commented we have a logical reason to do this on their behalf. This is another shared service. Mr. Malter asked do we already have a system set up? Mrs. Hurd-Harvey replied yes. A couple of years ago we moved this money, which was about \$100,000, into a trust account. The towns will continue to pay \$4,000 per town/per year into the account and then will use that money to purchase parts. Mr. Mullen asked what are the terms of the agreement in terms of ending? Ms. Prossick replied it is 30-days notice.

Mr. Mullen commented that he would prefer that the County was out altogether, but he will not oppose this.

I. CALL TO ORDER

Mr. Swackhamer called the meeting to order at 10:00 a.m. and led the Pledge of Allegiance.

II. APPROVAL OF MINUTES

III. LANDFILLS

A. *Leachate Treatment Plant Tank Restoration* – Mr. Spagnoletti requested approval of a change order from \$109,585 to \$83,304.

B. *RFP for Re-Use of Good Material* – Mr. Spagnoletti requested authorization to issue an RFP for the re-use of good material disposed at the Landfill and Transfer Stations.

C. *Tonnage Limit Permit* – Mr. Spagnoletti informed the committee they were at risk of going over their tonnage permit for the quarter. We should average 500 tons or less per day. We temporarily stopped receiving loads from various haulers, which put us in at 495 tons for this past quarter. This is something that is happening to everyone as garbage has increased. We are submitting an application to the DEC to raise our tonnage permit.

Mr. Roush asked is the increase in garbage related to packaging? Mr. Spagnoletti replied he does not know the answer to that. Generally, an increase in garbage correlates to the economy improving. Mr. Roush asked if it were related to packaging, it may be a recycling issue. We will have to somehow accommodate more recycling. Mr. Spagnoletti commented packaging is a real issue.

Mr. Malter asked what is going to be the new tonnage limit if your application is approved? Mr. Spagnoletti replied we are requesting an increase of 100,000 tons.

Mr. Swackhamer asked how is the electronics recycling going? Mr. Orcutt replied it has slowed down. Mr. Nichols stated there are people dumping their televisions at the Painted Post Rod & Gun Club. Mr. Mullen commented we should revisit the cost that we are charging. Mr. Spagnoletti stated that he will come back next month with an analysis.

Mrs. Ferratella stated she has noticed that a lot of people do not have recyclables out with their garbage. Can we promote recycling? Mr. Spagnoletti replied the only thing we can do that is to look at the trucks to see if recycling has been taken out. We cannot force people to recycle at the curb. Mr. Wheeler stated enforcement is difficult. Mr. Spagnoletti stated he will do an analysis of this. Mr. Wheeler commented we could certainly do more public relations. Mr. Mullen stated we could also look at single stream.

Mr. Malter asked going back to the televisions, he is assuming we are getting a lot of old televisions? Mr. Orcutt replied yes. Mr. Malter stated so the cost should come down with more flat screens as they weigh less. Mr. Spagnoletti stated if we do away with the charge, we will get more televisions in. With regard to recycling, the simplest thing to do is single stream. We have a good, money making program now when we separate. When you single stream, you get paid very little, or you pay the vendor to take it. We could do a much broader public relations program.

Mr. Malter asked is the purpose of single stream so that people don't have to separate the recyclables? Mr. Spagnoletti replied with single stream the volume goes up 15 – 20 percent. Discussion followed.

IV. HIGHWAYS

A. *Shared Services Agreement with Allegany County for Whitesville Radio Tower Site* – Mr. Wheeler stated this was discussed this morning at the Public Safety & Corrections Committee. From Mr. Marshall's standpoint, it would be beneficial to partner with Allegany County on the construction of the site in Whitesville. We are working with Allegany County as there are some questions about the easement. This will be a good shared services effort if we can get it done.

Mr. Mullen stated he would be interested in knowing the man-hours, material costs, etc. to do this. Mr. Wheeler stated we will be coming back to the committee with this next month.

V. BIDS

A. *Portland Cement Concrete; Heated*

There are many people that lie about bringing in garbage. We recently did a random check at the landfill and out of six people asked, four of them lied. He stated the Law Department had no issues with them issuing a \$20 landfill ticket as a refund.

I. CALL TO ORDER

Mr. Swackhamer called the meeting to order at 9:30 a.m.

II. GENERAL BUSINESS

A. Emergency Management Office

1. **Whitesville Tower Site** – Mr. Marshall explained Allegany County is building a new tower in Whitesville and have asked us to partner with them. They are putting up the tower and are asking for our help from Public Works for grading and compacting of stone. Allegany County will be spending \$1 million on this project. Our contribution will be manpower, equipment and stone. This will give us the opportunity to co-locate our radio communications on that tower.

Mr. Farrand asked what are the costs? Mr. Marshall explained that looking long-term, the tower site we have in Jasper is owned by Crowne Castle who is notorious for their high lease rates. We would like to make some changes to that tower, but if we do, then they will charge us a \$30,000 per year lease fee. If we eliminate the Jasper site, we will move to the Travis Hill site and build out the Whitesville tower site. Over twenty years, we will see a savings of \$600,000 or more in lease costs.

Mr. Farrand asked what will be the initial cost to transfer? Mr. Marshall replied the Whitesville tower site will be a new build and that will be covered by grant funds. We will also need to build out the fiber. The Travis Hill site will be a build out of the fiber. Mr. Wheeler commented this work will happen when we receive the grant funding.

Mr. Spagnoletti stated that the total cost for his department will be \$35,000 - \$45,000. The materials cost will be \$15,000 - \$20,000. Mr. Malter asked will the cost to Public Works be reimbursed with the grant funds? Mr. Wheeler replied in his view it will be considered shared services.

I. CALL TO ORDER

Mr. Swackhamer called the meeting to order at 10:00 a.m. and led the Pledge of Allegiance.

II. APPROVAL OF MINUTES

MOTION: APPROVING THE MINUTES OF THE OCTOBER 2, 2017, AND OCTOBER 23, 2017, MEETINGS MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

III. LANDFILL

A. *Contract Renewal – Cooper Tank* – Mr. Spagnoletti requested authorization to renew the contract with Cooper Tank for processed construction and demolition debris cover material at a rate of \$15.00 per ton.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO RENEW THE CONTRACT WITH COOPER TANK FOR PROCESSED CONSTRUCTION AND DEMOLITION DEBRIS COVER MATERIAL AT A RATE OF \$15.00 PER TON MADE BY MR. ROUSH. SECONDED BY MR. MULLEN. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

B. *Change Order* – Mr. Spagnoletti informed the committee they had budgeted \$216,000 to replace the hardware and software at the leachate treatment plant. Since the bid, there has been a flow meter replacement on Cell1; also found that Cell 2 was not compatible and then we also did Cell 3 so everything would be standardized. Additionally, we found that we were having difficulty with the fresh water supply, so we reconfigured the wiring. We also customized the standard operating program so that we have the ability to adjust the treatment process to accommodate different leachate types. The total amount of the change order is \$39,873. Mr. Orcutt commented we are \$15,000 short and he requested authorization to transfer \$15,000 from the Leachate Treatment Plant Repair Capital Project to the SCADA Capital Project. Mr. Wheeler commented with the affluent we send to the Bath Water Treatment Plant, there are new regulations and we are trying to work with them. Having the ability to have data from this new system will be important in the future.

MOTION: AUTHORIZING A CHANGE ORDER RELATIVE TO THE SCADA SYSTEM AT THE LEACHATE TREATMENT PLAN IN THE AMOUNT OF \$39,873 TO PLANT IQ, INC. AND AUTHORIZING THE TRANSFER OF \$15,000 FROM THE LEACHATE CAPITAL PROJECT TO THE SCADA CAPITAL PROJECT TO COVER THE ADDITIONAL COSTS MADE BY MR. NICHOLS. SECONDED BY MR. ROUSH. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

C. *TV's and Computer Monitors Program Update* – Mr. Spagnoletti stated last month there was a discussion regarding whether we should continue charging the \$20 recycling fee or not. He distributed an analysis of the program which shows that if we did not charge, we would see a net loss of \$33,906. With the \$20 charge, we see a surplus of approximately \$9,100.

Mr. Malter asked what accounts for the reduction in the number of pounds? Mr. Spagnoletti replied that takes into account if we were to charge \$20 that they would take them someplace else. Mr. Wheeler commented reimbursement from the Department of Environmental Conservation is tenuous and there are still caps in place.

Mr. Malter asked would you have a break even situation if you charged \$15? Mr. Spagnoletti replied you would still lose \$3,000. Mr. Nichols commented his concern is if we charge \$20, where are the TV's and monitors showing up.

Mr. Mullen asked what do you think will happen if we dropped the fee down? Mr. Swackhamer commented nothing. He has thought about offering a no cost two-week period after Christmas for people to bring in their TV's and monitors.

Mr. Nichols commented that he would like to see the 2015 tonnage rate for TV's and monitors. Mr. Mullen commented that he would like to revisit this topic again.

D. *Recycling Program Update* – Mr. Spagnoletti stated last month Mrs. Ferratella had asked about our recycling program and if we could do more recycling and promote more public awareness. We are running a deficit of \$57,097. Each ton of recycling represents a \$30.00 per ton cost to us. You could go to single-stream recycling which would bump up your tonnage by 15 – 20 percent, but you would not get \$142,000 in revenue. Another option would be to hire a recycling coordinator. The salary would be \$64,000 and the State would reimbursement one-half, which would be \$32,000.

Mr. Wheeler commented our intern, Brooke Clark, has done a good job doing research for us to get more ideas on public relations and what we can do to update our website.

Mr. Hanna asked how will the news about China affect us? Mr. Bills replied China controls the recycling market for the most part. They have decided to increase the level of quality they want to accept. A lot of material previously marketable will not meet their new standards. The amount of revenue we receive may drop.

Mrs. Ferratella asked would it be more cost effective to put it in the Landfill? Mr. Spagnoletti replied he has been doing an analysis regarding the cost of recycling versus putting in the Landfill. Once that analysis is complete, he will present it to the committee.

IV. HIGHWAYS

A. *Request to Purchase Two Sanders* – Mr. Spagnoletti requested authorization to purchase two sanders for pickup trucks at the Howard and Prattsburgh shops. Mr. Nichols asked are these ¾ ton pickups? Mr. Rapalee replied they are 1 ton pickups.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO PURCHASE TWO SANDERS FOR PICKUP TRUCKS AT THE HOWARD AND PRATTSBURGH SHOPS; ADDING THE SANDERS TO THE MAJOR EQUIPMENT LIST AND TRANSFERRING \$9,200 FROM PLOW PARTS TO MAJOR EQUIPMENT MADE BY MR. MULLEN. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

B. *CR 122 Storm Water Pipe Project* – Mr. Spagnoletti informed the committee that they had CR 122 on the road project list for paving and milling, however, we need to replace the storm drain first. He requested authorization to create a new capital project entitled “CR 122 Storm Water Pipe” and to transfer \$205,000 from the CR 122 road project to the new capital project.

C. *Road Program Update* – Mr. Spagnoletti provided the committee with a review of the Road Program. Mr. Hauryski stated since he has been a Legislator, there has been a five year plan in place and we have seen the benefits of that. One comment that has been constant over the past few years is the quality of our roads. He commends Mr. Spagnoletti’s workforce for the quality of work they have been doing.

Mr. Malter asked when will you put the next five year plan together? Mr. Spagnoletti replied in 2019. The current plan ends in 2020 and we usually do a new plan the year prior.

Mr. Nichols commented Mr. Spagnoletti has gone and put bases under the roads so they will hold up, and we are seeing the results of that.

I. CALL TO ORDER

Mr. Swackhamer called the meeting to order at 10:00 a.m. and asked Mr. Roush to lead the Pledge of Allegiance.

II. APPROVAL OF MINUTES

Mr. Mullen commented that on the motion awarding the bid for the Clean & Inspect Landfill Leachate Holding Tanks and Lines, the total should be \$44,976.50.

MOTION: APPROVING THE MINUTES OF THE NOVEMBER 6, 2017, MEETING AS AMENDED MADE BY MR. NICHOLS. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 5-0.

III. LANDFILLS

A. *\$20 Fee for TV's and Computer Monitors* – Mr. Mullen distributed a handout of the costs that he had worked out. From the numbers we had received from Mr. Spagnoletti, the cost is \$16.00 per unit. If we had a charge of \$15.00 per unit, it would cost us \$3,100. That also assumes we have more volume. He stated that he would propose changing the fee to \$15.00 and see how it goes next year. That fee may be more affordable for people.

MOTION: ESTABLISHING A TIPPING FEE OF \$15.00 PER UNIT FOR TV'S AND COMPUTER MONITORS, EFFECTIVE JANUARY 1, 2018 MADE BY MR. MULLEN. SECONDED BY MR. NICHOLS FOR DISCUSSION.

Mr. Roush stated that he is okay with keeping the \$20 charge and he does not see a reason to change. Mr. Van Etten asked what explains the two-thirds drop in tonnage if you go from no charge to a charge? Where are the TV's and monitors going? Mr. Spagnoletti replied we did think that it's possible people are holding onto them and just not bringing them in. We do not see anything significant on the roadsides.

Mr. Van Etten commented the weight of televisions is dropping significantly and it may be that people from neighboring counties are bringing them to us. Mr. Mullen stated he thinks a \$20.00 charge is too much to have people bring in their

TV's and computer monitors. Mr. Spagnoletti replied that \$20.00 charge does not represent our full cost; there is also a big labor component.

VOTE ON PREVIOUS MOTION: MOTION CARRIES 3-2 (MR. ROUSH AND MR. MALTER OPPOSED)
Resolution Required.

IV. HIGHWAYS

A. *Tappan Zee Bridge Panels Agreement with NYS Thruway Authority* – Mr. Spagnoletti informed the committee that the State is taking down the Tappan Zee Bridge and have agreed to deliver and unload the panels at their cost. We would be receiving six panels that are 12'6" wide x 50' long. He requested authorization to sign an agreement with the NYS Thruway Authority to accept these panels. This will save us about \$150,000 - \$160,000 and will enable us to do three bridges.

MOTION: AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO ENTER INTO AN AGREEMENT WITH THE NEW YORK STATE THRUWAY AUTHORITY TO ACCEPT SIX PANELS FROM THE TAPPAN ZEE BRIDGE MADE BY MR. ROUSH. SECONDED BY MR. MALTER FOR DISCUSSION.

Mr. Malter asked how does this information get into the paper two to three weeks before it even comes to committee? Mr. Wheeler replied the State announced about six months ago how many panels they were allocating to each county.

VOTE ON PREVIOUS MOTION: ALL BEING IN FAVOR. MOTION CARRIES 5-0.

B. *SEQR Approval for New Caton Shop* – Mr. Spagnoletti requested the committee declare Steuben County the lead agency and issue a negative declaration on the Caton Shop. This declaration states that there will be little to no impact on the environment.

Mr. Mullen asked does the 150'x60' include the plans for expansion? Mr. Spagnoletti replied we are planning to construct a building that is 110' long with the option to extend. Mr. Mullen asked why will there be a holding tank instead of a regular septic system? Mr. Spagnoletti replied we are very close to a wetland. We have holding tanks at other shops and it works well.

MOTION: DECLARING STEUBEN COUNTY THE LEAD AGENCY RELATIVE TO SEQR AND ISSUING A NEGATIVE DECLARATION FOR THE NEW CATON SHOP MADE BY MR. ROUSH. SECONDED BY MR. MALTER. ALL BEING IN FAVOR. MOTION CARRIES 5-0. Resolution Required.

The cost will be \$2,400 for drilling and \$1,500 for the evaluation; bringing the total change order to \$3,900 allowing Labella to drill three holes and do the evaluation.

Mr. Spagnoletti replied it is an estimate. Mr. Eggleston explained we dug some test holes and we found sand and some stone that is not big enough for our operations. Mr. Malter asked how much gravel have we taken out? Mr. Spagnoletti replied over the course of several years we have taken out about 1 million tons of sand and gravel. Coarse sand represents about one-half of that. Mr. Malter asked what would be the dollar equivalent? Mr. Spagnoletti replied about \$1.5 million.

Mr. Mullen asked do we have to bond for reclamation? Mr. Spagnoletti stated part of the sale includes a requirement that we are supposed to do that. Mr. Eggleston stated it costs about \$6,000 per acre to reclaim and that was part of the total.

VI. OTHER BUSINESS

A. *Purchase of Two Mowers* – Mr. Spagnoletti informed the committee that the Town of Hornellsville has two mowers that they would like to sell. One mower is \$27,000 and the other is \$32,000. He requested authorization to purchase the two mowers for \$59,000 and to amend the Landfill Major Equipment list.

B. *Liquid Asphalt Injection* - Mr. Spagnoletti stated last month there had been a question regarding the life of the injected liquid asphalt. When you inject oil into the road base, that oil does not go away and is pretty much there permanently. With a nine-inch base, we just recycle the blacktop on top.

C. *Landfill Tonnage Increase* – Mr. Spagnoletti stated last month there had been a question regarding the increase in tonnage at the Landfill. Because the Legislature agreed with the idea of charging variable rates, that has allowed us to get more tonnage, which has made a huge difference.

D. *Cameron Bridge Project* – Mr. Spagnoletti stated he recently attended a Cameron Town Meeting where they discussed the new bridge project over the Canisteo River. This project is scheduled for 2019 and we will be closing it down to one lane. There was an individual in attendance who was expressing his displeasure at that. Mr. Spagnoletti stated these are \$3 - \$4 million bridges. We wait for the Federal funding and then the County share is only 3 – 5 percent. For that reason, we have to adjust it down to one lane.

E. *January Meeting Date* – Due to the New Year’s holiday, it was recommended to move the January meeting to Monday, January 8, 2018 at 10:00 a.m.
